INTECH'S INVESTMENT PHILOSOPHY


- The capitalization-weighted index is not efficient and can be improved upon by varying portfolio weights based on the volatilities and correlations of stocks.
- Positive excess returns can be achieved over the long term using only estimates of volatilities and correlations, through systematic rebalancing.
- The opportunity for positive excess returns through rebalancing is demonstrated by Stochastic Portfolio Theory and further illustrated by the historical stability of the market's capital distribution.



The objective is to outperform the benchmark over the full market cycle, with an expected tracking error of 3-4%. The composite was created in June 2013.

The MSCI Emerging Markets Index is a free float-adjusted market capitalization-weighted index that is designed to measure performance of emerging equity markets.

The Index returns are provided to represent the investment environment existing during the time periods shown and are not covered by the report of independent verifiers. For comparison purposes, the index is fully invested, which includes the reinvestment of dividends and capital gains. The returns for the index do not include any transactions costs, management fees or other costs, and are gross of dividend tax withholdings unless otherwise noted. Composition of each separately managed account portfolio may differ from securities in the corresponding benchmark index. The index is used as a performance benchmark only, as INTECH does not attempt to replicate an index. The weightings of securities within the portfolio may differ significantly from the weighting within the index.
