#### PRODUCT OBJECTIVE

Outperform the index, over the full market cycle, within the expected tracking error range.

#### INTECH'S INVESTMENT PHILOSOPHY

- The capitalization-weighted index is not efficient and can be improved upon by varying portfolio weights based on the volatilities and correlations of stocks.
- Positive excess returns can be achieved over the long term using only estimates of volatilities and correlations, through systematic rebalancing.
- The opportunity for positive excess returns through rebalancing is demonstrated by Stochastic Portfolio Theory and further illustrated by the historical stability of the market's capital distribution.

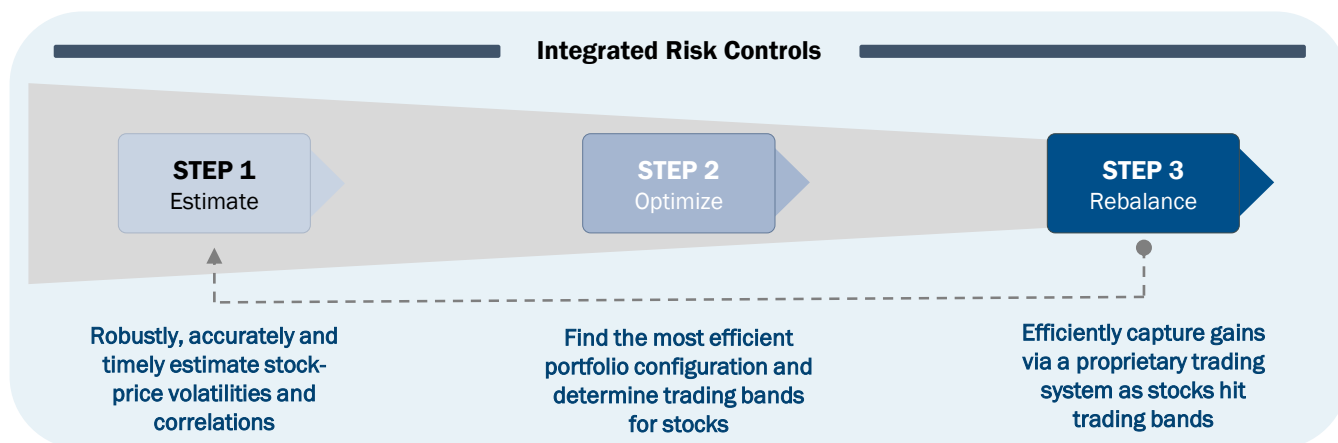

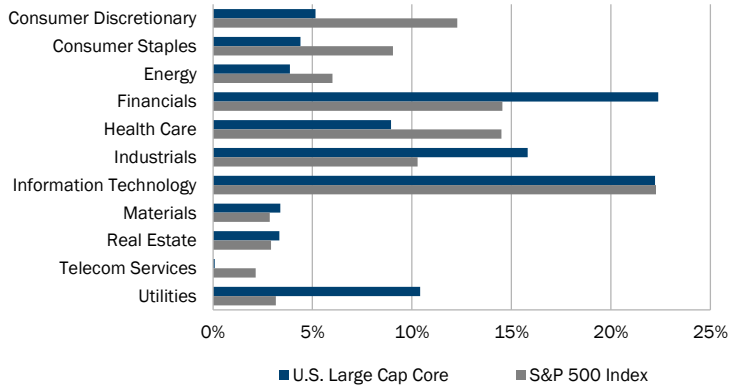

The objective is to outperform the benchmark over the full market cycle, with an expected tracking error of 4-5%. From January 1997 through June 2001, the composite contained one non-fee paying account managed for the then parent company. The composite was created in January 1993.

The S&P 500 Index is an unmanaged index of 500 stocks that is generally representative of the performance of larger companies in the U.S.

The Index returns are provided to represent the investment environment existing during the time periods shown and are not covered by the report of independent verifiers. For comparison purposes, the index is fully invested, which includes the reinvestment of dividends and capital gains.
