## 2010 Foreign Taxes Paid

Foreign taxes paid by a mutual fund and passed through to its shareholders may be eligible for a federal tax deduction or credit. For 2010, the following funds qualified for and made the election to pass through foreign taxes paid by each fund to Class D Shares investors (the amount reported in box 6 of your Form 1099-DIV). The percent of ordinary income earned in 2010 (the amount reported in box 1a of Form 1099-DIV) attributable to income from foreign sources is provided below. Country by country reporting is no longer required.
