

2011 Janus FINAL Per Share Distribution Amounts

The remaining Janus equity and income funds will pay distributions, if any, on December 22, 2011 to shareholders of record on December 21, 2011. The regular monthly dividend for the Janus income funds, the Perkins Value Plus Income Fund and the INTECH Global Dividend Fund will be paid on December 30, 2011.

The funds intend to distribute the maximum amount of dividends qualifying for the 15% rate allowable under the law.

Please note that the record date for the Janus Asset Allocation funds' distributions is December 27, 2011 and the payable date is December 28, 2011.
